Submitted photos may be shared on our social media and our website.

LOCATION/COURSE: Ever wish you could pick the perfect location and conditions for optimum success? Now you can! Log miles around your neighborhood, local track, hiking trail, or community pool. Challenge your friends and family to see what you really can do! You decide how and when you schedule your challenge time: everyday, on the weekends, 3x a week, whatever fits your schedule. When ready, go out and summon your power to run, walk, bike, swim, or “fly” to help Dauphin County CASA.
